By signing below, your organization (Organization), _____ at address _____

City, _____ ST _____ Zip _____ agrees to each of the following stipulations of agreement. The Sergei Foundation reserves the right to terminate this license agreement at any time for any reason at its sole discretion, without limiting the foregoing, for not complying with the terms of conditions of this agreement, or rude or illegal behavior. Termination may include requiring the Organization to cease operations and leave the event without reimbursement:

- Organization will be present during all vendor hours for days agreed to on the vendor application form or via email: May 18, 2019 10am-3pm at the Winston-Salem Fairgrounds.
- Organization will only set up/take down only during specified hours of 8:30-9:30am unless earlier times are approved by The Sergei Foundation.
- Wrist bands must be worn by vendor staff for free entry (4 wristbands given per vendor). Otherwise admission must be paid upon entry. Additional wristbands may be purchased if more than 4 are needed.
- A 10' X 10' outdoor space will be provided. Spaces will be assigned at set-up during check in. All vendors will be located outside between the main entrance to the outdoor events.
- The Sergei Foundation, via The Fairgrounds, will provide one (1) 8-foot table and two (2) chairs. If more are needed, please indicate that here. **Extra tables:** _____ **Extra chairs:** _____
- Your organization will be responsible for tents and any additional supplies/equipment if needed.
- If tents are used, Organization must use tent stakes in all four corners of the tent to secure from wind/weather OR 10 lb tent weights may be used on all four corners. (This will be verified by Fairgrounds staff, and you may not be able to keep the tent up if it is not secured properly).
- Organization may not promote or provide any of its vendor space to any other person or business for any reason. Only the Organization may be represented/promoted at the Event.
- No solicitation/roaming outside of your vendor space areas.
- Organization agrees to clean up after itself and any pets. Please bring a water bowl for pets to use.
- No altering of grounds/property.
- Free items for giveaways are allowed, but all pre-packaged/purchased dog treats must have the bags or boxes visible for people to view ingredients. No plastic frisbee giveaways allowed (harmful to pets).
- No rain date; this is a rain or shine event. Vendors who do not show up or who do not stay for their scheduled time may not be invited back or included in future Triad Dog Game events. If outdoor events are cancelled, indoor space will be provided. If for some reason the entire event is cancelled, monies will be applied to the next Triad Dog Games event.
- Organization agrees to defend, indemnify and hold harmless The Sergei Foundation, The City of Winston-Salem, The Winston-Salem Fairgrounds, and all volunteers, officers and contractors from these organizations against any loss, damage or expense (including reasonable attorney's fees) incurred by The Sergei Foundation in connection with or as a result of any claim for personal injury or property damage arising from your organization's activities whether intentional, knowing, reckless or negligent at Triad Dog Games.
